## HISTORY OF WILTSHIRE HISTORIC CHURCHES TRUST

### EXECUTIVE SUMMARY

This brief history by Michael Hodges traces the national start of fundraising for church buildings to the start of the 19th century. The Historic Churches Preservation Trust (now the National Churches Trust) was set up under royal patronage in 1953 with a view to county organisations also being set up.

The then Bishop of Salisbury asked the then Lord Lieutenant of Wiltshire (the 16th Duke of Somerset) to set up a county meeting to discuss how to proceed in Wiltshire. This meeting was duly convened at the County Hall at Trowbridge on 17th February 1953. It was agreed at the meeting that the Wiltshire Historic Churches Trust should be set up with the aim of raising £50,000 over ten years. An inaugural service was held in Salisbury Cathedral on 1st June 1954 and the Trust Deed was signed on 11th November 1954.

Progress was fairly slow over the next thirty years until 1985 when the first Great Bicycle Ride (subsequently "Ride and Stride") was held. This increased the amount of funds available for grants. Between 1954 and 2008 the Wiltshire Historic Churches Trust disbursed grants of £345,000.

In the autumn of 2008, the Friends of Wiltshire Churches was set up as a membership body of the Wiltshire Historic Churches Trust. By the end of 2010 membership had reached a total of some 420 individuals, a level at which it has broadly remained subsequently. A programme of excursions, social events and lectures was set up and this continues to this day. Various relevant books were also published, such as Brian Woodruffe's "Parish Churches of Wiltshire". Grants to churches totalling £940,284 were made in the period between between 2008 and 2022.



## HISTORY OF WILTSHIRE HISTORIC CHURCHES TRUST

### FULL HISTORY BY MICHAEL HODGES

The initial attempt at providing funds for the repair of churches on a national basis started in the first half of the 19th century. In 1818 the Society for Promoting the Enlargement and Building of Churches and Chapels was founded to provide funds for the building and enlargement of Anglican churches throughout England and Wales. The Society was incorporated by an Act of Parliament in

1828 as The Incorporated Society for Promoting the Enlargement, Building and Repairing of Churches and Chapels. Later in the century it adopted the title of The Incorporated Church Building Society. Since 1982 the Society's administration has been transferred to the Historic Churches Preservation Trust.

The Historic Churches Preservation Trust (since 2007 the National Churches Trust) was founded in 1953 by the then Bishops of Chester and Stockport to restore architecturally and historically significant parish churches. This followed a report issued by the Commission on the Repair of Churches, appointed by the Church Assembly, which calculated that the sum of money required for the next ten years to supplement parochial efforts in putting churches in the country into good repair would be £4 million. Her Majesty the late Queen consented to be President and HRH the late Duke of Edinburgh the Patron. In its Report the Commission stated that the Historic Churches Preservation Trust would need not only to launch a national appeal but to work through area organisations, preferably on a county basis.

The Bishop of Salisbury asked the (16th) Duke of Somerset DSO, OBE, Lord Lieutenant of Wiltshire from 1942 to 1954, to convene a meeting of "people prominent in the life of the County, including all Mayors and Chairmen of Urban and Rural District Councils" with a view to setting up a county trust to help raise part of the sum required. The Duke wrote from Maiden Bradley asking interested parties to attend a meeting at County Hall, Trowbridge on 17th February 1953 to discuss the question and to hear the Rt Rev William Anderson, Bishop of Salisbury and Ivor Bulmer-Thomas, the Chairman of the Executive Committee of the Historic Churches Preservation Trust, "who is making a special visit and will describe the extent of the problem of repairs to Parochial Churches and make suggestions for the constitution of a standard Trust for the Preservation of Wiltshire Churches in affiliation to the national body."

The meeting at County Hall, Trowbridge was duly held on 17th February 1953. The Wiltshire Historic Churches Trust was subsequently set up under the Presidency of the Duke of Somerset with the Bishops of Bristol and Salisbury as Vice Presidents.

Wiltshire responded to the call earlier than many other counties. Of the neighbouring ones, their trusts were set up as follows: - Dorset (1960), Oxfordshire (1964), Gloucestershire (1981), Berkshire (1984), Hampshire (1988) and Somerset (1996). Further afield even Norfolk took until 1976 under the dynamic chairmanship of Billa Harrod to set up its trust.

On 1st June 1954 an evening inaugural service was held at Salisbury Cathedral by permission of the Dean and Chapter. Representatives were asked from every Anglican parish in Wiltshire. The Choir sang Parry's "I was glad when they said unto me, we will go into the house of the Lord." as the first anthem.

The Dean said the initial prayer - "Brethren, we bid you welcome to our Cathedral Church of Salisbury to inaugurate with prayer and praise the Wiltshire Historic Churches Trust. We bid you give thanks to God (whom Heaven and the Heaven of heavens cannot contain, much less the houses we have builded) for every Church and Chapel built and preserved for our use through twelve centuries and more to be a House of God; wherein we receive the comfort of His Word and Sacraments, are made his children, joined by him in Holy Matrimony, and brought in our turn to our last earthly resting-place. And we bid you pray that He may guide and prosper the work of this Trust; that as we have entered into the labour of others, so others may enter into ours; that our Churches and Chapels may be preserved in the beauty of holiness, revered as the place where His honour dwelleth, and lived and used among us as the Gate of Heaven."

The second anthem was Brahms' German Requiem - "How lovely are Thy dwellings fair, O Lord of Hosts". The Bishop of Bristol preached. Various hymns were sung; during the last ("We love the place, O God, wherein Thine honour dwells.") a collection was taken for the Wiltshire Historic

Churches Trust which appealed to “men and women of all denominations to help meet this national obligation.” It went on to say “The parish churches of England are a great national glory. The history of England is written in their monuments. They have moulded the characteristics of our towns and villages for a thousand years or more. This noble heritage is in danger of decay.” Subscriptions could be sent to Lloyds Bank, Salisbury.

The Trust Deed of the Wiltshire Historic Churches Trust was signed on 11th November 1954. The Duke of Somerset had by then died and been replaced as Lord Lieutenant by Lord Herbert CVO (16th Earl of Pembroke 1960-69). The Lord Lieutenant of Wiltshire and the Bishops of Bristol and Salisbury were to be ex-officio trustees. The objects of the trust were described as follows: - “the preservation, repair, maintenance, improvement, upkeep, beautification and reconstruction of churches in Wiltshire and of monuments, fittings, fixtures, stained glass, furniture, ornaments and chattels in such churches, and of the churchyard belonging to any of such churches.”.

The initial fundraising target was set at £50,000 over ten years.

On 1st March 1958 the President of the Wiltshire Historic Churches Trust, Lord Herbert, made his report. He noted the trust had been running for nearly four years and was very much behind its target. £6,500 had been raised so far, against mainly setting up expenses of £387. Grants had been made to over 50 churches amounting in all to £3,120. “Unfortunately, these Grants are only a fraction of what is required...We have, therefore, much leeway to make up and further big efforts will have to be made if we are to achieve our object.”

In 1968 the trust produced a booklet with a blue cover entitled “A Tour of Wiltshire Churches.” This was printed by The Friary Press in Dorchester and initially retailed at 10 shillings. It contains a considerable number of black and white photographs. The unknown author meanders through the county covering some one hundred churches, starting in the north and eventually ending in the south. The churches are all Anglican with the exception of brief mentions for the 18th century chapel of All Saints, Wardour and the 16th century Presbyterian meeting house at Horningsham.

In 1973 (the 1st) Lord Margadale, Lord Lieutenant 1969-81, and President of the Wiltshire Historic Churches Trust, wrote a fairly pessimistic report “The Trust may have to close down in a few years’ time unless the annual income can be substantially increased. The policy has been to authorise realistic grants to enable the fabric of historic churches to be kept in sound condition. With ever rising costs it has been necessary to allot £4,400 per year for the last three years...the average annual income, apart from two exceptional years, ‘61 and ‘68, has been less than £2,400, although over £3,000 has been collected each year recently; and altogether 221 churches have been benefited by grants of over £45,000...Income from covenants and subscriptions showed little change, and I again appeal to every Parish Council in the County to subscribe to the Trust as much as possible, surely in most cases a form of enlightened self-interest.”

The trust did in fact survive in spite of Lord Margadale’s gloomy prognostication. 1985 was somewhat of an annus mirabilis. The President, Sir Hugh Brassey, Lord Lieutenant of Wiltshire 1981-89, was able to report as follows: - “The big fund-raising event of the year was the sponsored Great Bicycle Ride which was held throughout the county on Saturday 6th July. This raised a sum in excess of £20,000, half of which went to the churches sponsoring the cyclists and, after deducting a small amount for expenses and prizes, the Wiltshire Historic Churches Trust benefitted by the sum of £8,580. This injection of money has enabled the annual grants to be raised by £1,000 so that the allocation is now £1,750 to both the Sarum and Wilts Archdeaonries and £1,500 to Swindon. Sponsored cycle rides for Historic Churches are about to become a national annual event and for 1986 the date is to be 6th September. If the 1985 result can be repeated as successfully, the grants can be further increased. A logo has been designed for the Trust and it is shown on the cover of this report. The design shows Purton Church, which is one of

the only three in England to have both a tower and a spire. Finally, a new leaflet setting out the aims of the Trust has been produced and distributed outlining its work and aims.”

Wiltshire was one of the earliest counties to start raising awareness and valued funds through this popular outdoors annual event. The Great Bicycle Ride (subsequently renamed nationally “Ride and Stride”) was invented in Suffolk in 1982 and provided a major lifeline to the Wiltshire Historic Churches Trust. The first organiser in Wiltshire wrote in 1985 “...The Ride in 1984, organised in North Wiltshire alone, produced £10,700, half of which was immediately returned to each cyclist’s chosen church, and in 1985 the result for North Wiltshire and mid-Wilts was a grand total of £20,500, half being retained by the Trust. This increase in capital is changing the outlook within the Trust to optimism for the future. The Trust members who organised the Ride feel confident that a first target of achieving £50,000 capital in the Trust is within reach within two or three years, and then we should aim at £100,000 plus.... A total of 711 cyclists took part.” The Oaksey Trust was thanked for providing the prizes.

The bicycle ride became a national event in 1986 and until the foundation of the Friends of Wiltshire Churches in 2008 was very much the major source of funds for the Wiltshire Historic Churches Trust. It, for instance, provided £5,381 in 1984, £14,500 in 1995, £32,750 in 2005, £26,962 in 2015 and £27,967 in 2022 with the overall totals raised for churches in Wiltshire being around double those figures year on year. 2022 provided the highest overall contribution so far, with a total of £53,669 raised in support of Wiltshire churches and chapels and Trust grants. The number of participants has since 1998 varied between 200 and 300. The total raised to date for the trust amounts to £841,101 (£1,716,578 in total, with half going to individual churches).

As President of the Friends of Wiltshire Churches, Lord Brooke donated two cups for annual award to the adult Ride and Stride team and to the junior Ride and Stride team that contributed the most participation and funds.

The opening of churches on Ride and Stride Day is also a major benefit to local communities with participants enjoying a warm welcome and refreshments around the county. 2022 provided an exceptional and memorable day with participants visiting churches with Books of Condolence open for signature by their many visitors, from far and wide, who wished to record their reflections after the death of the late Queen Elizabeth.

The Trust has also managed to build up a certain amount of assets through legacies, gifts from individuals and parishes, and retained income. By 30th September 2008 these were valued at £170,000. The assets have for some years been managed very competently by CCLA.

At the end of March 2021, the net assets of the trust had increased to £547,018. This amount consisted of unrestricted funds of £423,726 and the Hartham Church Charitable Trust Fund (“HCCTF”) restricted fund of £123,282. The latter fund (initially, on transfer, of £100,000) was transferred to the Wiltshire Historic Churches Trust in 2018 and the income is available for churches which stand out for their contribution in advancing the Christian religion.

From 1954 to 2008 the Wiltshire Historic Churches Trust assisted nearly 200 chapels and churches with grants of £345,000. Most of this inevitably went to Anglican churches but Roman Catholic and nonconformist churches have never been excluded from consideration.

In 2008 the Wiltshire Historic Churches Trust made grants totalling £62,000. This contrasted with neighbouring counties as follows: -

Berkshire - £53,000

Dorset - £85,000

Gloucestershire - £132,000

Hampshire - £58,000  
Oxfordshire - £207,000  
Somerset - £61,000

(These were all rather cast into the shade by Norfolk with £499,000).

In 2008 the income of all the county trusts totalled £3,817,000. The National Churches Trust had an income of £1,609,000.

In the autumn of 2008 the Venerable Alan Jeans, Archdeacon of Sarum, then Chairman of the Wiltshire Historic approached Michael Hodges, a Roman Catholic banker with HSBC in London but with a cottage in Fonthill Gifford, to ask if he would be willing to set up a membership body, under his chairmanship, to be called the Friends of Wiltshire Churches. The introduction had come through Lady Egerton, then Chairman of the Norfolk Churches Trust. Wiltshire was until then fairly unique among county trusts in lacking any kind of membership body.

Michael Hodges had no very clear idea at the inception of how to set up such a body. He persuaded Lord Brooke of Sutton Mandeville to act as President of the Friends, which he remained until 2013 when he was succeeded by Mrs Sarah Rose Troughton, Lord Lieutenant of Wiltshire. Lord Brooke donated the Brooke Cup and the Brooke Junior Cup in respect of the "Ride and Stride" and for some years kindly donated additional prize money.

Michael's next move was to approach various individuals to ask if they would be willing to act as Vice Presidents of the Friends. Surprisingly few refused.

The list of Vice Presidents has remained remarkably stable from then until the end of March 2021. The personalities of the Bishops of Bristol and Salisbury changed. Michael Ancram retired when he ceased to be MP for Devizes. The 11th Lord Talbot of Malahide succeeded his father, the 10th Lord Talbot of Malahide, in 2016. The following individuals joined as Vice Presidents between 2009 and now: - The Bishop of Clifton, The Countess of Inchcape, Danny Kruger MP, Mrs Clare

Perry O'Neill, The Earl of Radnor, The Bishop of Ramsbury, Major General Sir Sebastian Roberts and the Dean of Salisbury.

The Committee of the Friends of Wiltshire Churches consisted of the following individuals in 2009:- Michael Hodges (Chairman), David Evans (Secretary), Peter Smith (Treasurer of the WHCT), Diana Beattie, The Hon. Edward Buchan, Richard Clarke, Anthony Edwards, Luke Hughes, The Ven Alan Jeans (Chairman of the WHCT), Morris Le Fleming, Diana Matthews Duncan, The Rev Morris Munns (Secretary of the WHCT), John Osborne, Christopher Rogers, Janet Ruddick, Sir Henry Rumbold Bt, Neil Skelton, Major James Thompson, Vicki Villers, Michael Wade and Brian Woodruffe.

At the end of March 2021 the membership was as follows:- Martin Knight (Chairman), David Evans, (Secretary), Fiona Lawley (Treasurer of the WHCT), Jeremy Groom (Membership Secretary), The Hon. Edward Buchan, His Honour Judge Mark Overall QC, Michael Hodges, Luke Hughes, Brigadier Nigel Jackson (Secretary of the WHCT), The Ven. Alan Jeans, Caroline Keevil, Clare Miles, John Osborne, Mark Robinson, Christopher Rogers, Neil Skelton and Geoffrey Till. Eight of the original Committee were still there.

The next problem was to attract a membership of the Friends. An initial launch party was held in London on 10th December 2009, courtesy of Michael Hoare, the Chairman of the National Churches Trust. A further launch party was held at Great Chalfield Manor on 24th June 2010, courtesy of Mr and Mrs Robert Floyd and the National Trust. 150 people attended the latter.

The social life of the Friends has continued undiminished until the present day with an annual summer party. A number of the early ones were held at Roche Court, courtesy of Madeleine, Countess of Bessborough. Diana Matthews-Duncan as Vice Chairman of the Friends arranged these various social events for a number of years.

156 members had joined the Friends by May 2009 and 280 by the end of the year. A year later the Friends numbered 420, a level which has subsequently remained broadly consistent. The first AGM of the Friends was held in St Thomas's Salisbury on 9th January 2010 and the constitution was adopted. The Rt Rev David Stancliffe, Bishop of Salisbury and Vice President of the Friends, gave a lecture entitled "When Wiltshire had only Two Churches; A Golden Age?" The tradition of an annual lecture at the AGM each spring has been maintained. In addition, lectures have been given each February on a variety of topics.

The first excursions were arranged by Michael Hodges in August and September 2009. The first went to Edington, Imber, Old Dilton and Sutton Veny. The second went to Wardour, Teffont Evias, Bishopstone and Stratford Tony. About 25 people attended each of these excursions. Thereafter four excursions were arranged each year. The majority of these have been led by Edward Buchan, Michael Hodges, John Osborne and Brian Woodruff. Berkshire, Dorset, Gloucestershire and Somerset have also all been "invaded" in the pursuit of suitable churches to visit.

The first Annual Report of the Friends of Wiltshire Churches was produced in 2009, generously sponsored by Luke Hughes, which he continued to do for a number of years.

The first literary venture of the Friends of Wiltshire Churches in 2009 was "Images from Wiltshire Churches" by the photographer Robert Tilleard. This retailed at £120 and sold to some thirty plus subscribers, headed by the then Duchess of Cornwall.

The second literary venture in 2010 was "The Parish Churches of Wiltshire" by Brian Woodruffe (with financial support provided by Michael Hodges). 2000 copies were printed and sold at £20 a copy. Members joining the Friends of Wiltshire Churches are now given a copy of the book. Brian

Woodruffe has also consistently made images available for the Christmas cards produced by the Friends.

The third literary venture in 2018 was “The Urns and Sepulchres of Mortality - The Church Monuments of Wiltshire” by Michael Hodges.

In the year to 31st March 2010 the Friends of Wiltshire Churches contributed £15,785 to the annual income of the Wiltshire Historic Churches Trust. In the year to 31st March 2022 this had increased to £20,405.

Michael Hodges retired as Chairman of the Friends on 23rd March 2013. He was succeeded for a year by His Honour Judge Mark Everall QC, another Roman Catholic, who then succeeded the Ven. Alan Jeans as Chairman of the Wiltshire Historic Churches Trust. Martin Knight succeeded as Chairman of the Friends in 2014 and continued in the role until April 2023 when he was replaced by Patrick Wintour DL.

The Wiltshire Historic Churches Trust has attracted a number of generous donations since the foundation of the Friends of Wiltshire Churches. The donors have included the Rev. Dr John Gosling, Mr Henry Hoare, The Inchcape Foundation, Lord Marland of Odstock and the Rothermere Foundation,

The Covid lockdowns of 2020 and 2021 inevitably caused a slowdown in activities such as excursions although the AGM and committee meetings continued through the medium of zoom.

From a committed start with lean resources and communication, the Wiltshire Historic Churches Trust has moved forward to its current secure state with finance and widespread personal and digital communications, such as a properly functioning website. It has since 2015 had an extremely energetic and competent secretary in the form of Brigadier Nigel Jackson. Everything is focused on the same issue - preserving and enhancing a unique array of historic churches and chapels as living places of worship across Wiltshire and including Swindon.



2023/4 is the 70th anniversary of the Wiltshire Historic Churches Trust which looks forward to its anniversary concert in Salisbury Cathedral on 25th November 2023 and a festive evensong at Malmesbury Abbey in the summer of 2024.
